**Fr Toby Karlowicz** is Canon Theologian in the Diocese of Quincy and assists at St Michael and All Angels Church in Peoria, where he teaches adult catechesis and helps with pastoral care. He has been a priest of the diocese for seventeen years, and has served on Diocesan Council and Ecclesiastical Court.

Outside the diocese, he has served on the Provincial Task Force on Holy Orders and on the writing and revisions committees of *To Be a Christian*, the official catechism of the Anglican Church in North America. He has also taught as an adjunct professor in liturgics and church history at Nashotah House Theological Seminary. Fr Toby is married to Becky, who is chair of Quincy International (which oversees the international outreach of the diocese, especially in Colombia) and is registrar and a lead counselor for Anglican Church Camp of the Midwest. They have two daughters, who are

active in serving at Church and in ACCM. Outside of church activities, Fr Toby is also a volunteer Cub Scout leader.

Fr Toby holds an M.Div. from Nashotah House and a Ph.D. in Divinity from the University of St Andrews in Scotland. As a theologian, he has published several theological papers as well as a booklength study of the theology of early Anglo-Catholic leader Edward Bouverie Pusey, and has been an invited speaker for conferences at Nashotah and at Pusey House in Oxford.

The Very Rev. Cn. J. Michael Strachan, Ph.D., serves as Rector of St. Dunstan's Anglican Church in Largo, Florida, where he has ministered for eight years. Ordained to the priesthood in the Diocese of Quincy by Bishop J. Alberto Morales, OSB, a decade ago, Fr. Michael has dedicated his ministry to biblical preaching, theological formation, and the renewal of the church's life in Christ.

In addition to his parish ministry, Fr. Michael serves the Diocese of Quincy as Canon to the Ordinary, assisting Bishop Morales with diocesan leadership, clergy support, and strategic initiatives. Over the years, he has held multiple leadership positions within the diocese, including service on the Diocesan Council, as Chair of the Commission on Ministry, and as Chair of the Finance Department.

Fr. Michael is deeply committed to the integration of Scripture, tradition, and mission. His preaching and teaching emphasize the unity of the biblical narrative, the Christ-centered fulfillment of the Old Testament, and the spiritual formation of God's people. He also writes regularly on Substack at On the Way, where he shares sermons and theological reflections.

He earned a B.A. in Biblical Studies from The Master's University, an M.A. in Biblical Exegesis and an M.A. in Biblical and Theological Studies from Wheaton College, a Th.M. in New Testament from Trinity Evangelical Divinity School, and a Ph.D. in Religious Studies from Marquette University, with a research focus on Judaism and Christianity in Antiquity.

Fr. Michael and his wife, Michelle, live in Largo with their two children, Anna and Joshua. Together they are passionate about cultivating a church that is rooted in Scripture, shaped by the historic faith, and open to God's mission in the world.

# REPORT OF THE TRUSTEES OF FUNDS AND PROPERTY OF THE DIOCESE OF QUINCY FOR THE FISCAL YEAR ENDED JUNE 30, 2025

The Trustees have responsibility for managing the investment funds for the Diocese. This includes the funds held for the benefit of the Diocese along with other special funds established at various times for particular purposes, parishes, or missions. The securities investments are held in a common investment account designated as the Pooled Investment Fund. The Pooled Investment Fund is held by Raymond James Financial Services, Inc.

The Bishop Alberto Morales Fund was established in January 2024 by the Diocesan Council. This fund represents the proceeds of the funds held by the Trustees for the benefit of Trinity Anglican Mission. The Mission was closed in 2023.

The Trustees own the church property at 4911 N. Knoxville, Peoria, Illinois. The property was purchased for the administrative offices of the Diocese and to house St. Michael and All Angels Church. The purchase price was \$550,000. The purchase was funded by a \$360,000 loan from Morton Community Bank with the balance coming from the Endowment Fund. The loan is secured by a mortgage on the property purchased. In December 2020, the Trustees extended the maturity of the loan to December 2030 with an interest rate of 3.7% for the next 5 years. The loan is repayable in monthly installments over 15 years. Operating expenses for the building are paid by St. Michael. The Diocese of Quincy pays a monthly reimbursement to St. Michael for approximately 30% of the operating costs. St. Michael pays the full amount of the monthly mortgage payments with no reimbursement from the Diocese. The balance on the mortgage loan was \$220,446 at June 30, 2025.

The Trustees held no closed churches under its care and management in Fiscal June 30, 2025.

The Trustees had no loans to affiliate entities in the Diocese of Quincy during Fiscal June 30, 2025.

The most recent audited financial statements available for the Trustees are for Fiscal June 30, 2024. The audit was completed by the CPA firm Phillips, Salmi and Associates. The FYE 6/30/2024 audit is available upon request. The Fiscal June 30, 2025 audit is in process.

### DIOCESAN DEANERIES

The new Saint Andrews Deanery-

### SAINT MICHAEL'S DEANERY

The newly constituted (or re-constituted) St. Michael's Deanery includes all the English-speaking congregations in Illinois, except for St. Patrick's in Mt. Vernon.

# ST. JOHN'S CATHEDRAL, QUINCY

St. John's celebrated the completion of several important building projects last year. We replaced the entire steel framing in our historic bell tower and added an electrically controlled, programable striker system to our 11-bell chime. The bells toll automatically at 8:00 am, noon, and 3:00 p.m. She also "calls us to worship" at 10:30 every Sunday morning. Additionally, we have entirely remodeled the northwest portion of our building to create a single, open, lofted, sacred space for our children's creative arts ministries. We call it the Anne-X, in honor of Anne Oakley, the mother of our two benefactors. By the end of this year, we will also have installed a new, interior columbarium. Maintenance of a 185+ year old building continues to challenge us, and yet our people continue to give sacrificially as the need arises. We have a new tagline: "Faith. Family. Fullness of Life." It's drawn directly from Ephesians 3 and reflects our renewed intention to disciple entire families in the way and life of Christ Jesus. We've had family-wide events, including a family mission trip to Guatemala (not just youth with a few adult chaperons, but youth along with "mom and dad"), and family service events such as national build-a-bed day with parents and their children building beds for other underserved families via the organization Sleep in Heavenly Peace.

New changes included the relocation of Fr. Dustin Hall and his family to Winter Garden, FL, and we've also welcomed Fr. Luke Engelmeyer as our new curate as he was ordained to the priesthood this past summer. We also celebrate his and Carley's new baby boy, little Jude Engelmeyer, born September 4.

# ST MICHAEL AND ALL ANGELS, PEORIA

St. Michael's joyously celebrated our tenth anniversary recently on Michaelmas, with our annual episcopal visit from Bishop Morales, and five confirmations. Of course, our history goes back much longer than ten years, with our merged congregations of St. Andrews and St. Francis dating to as early as 1897.

We continue to attract new families (with kids, thanks be to God!), and we now have three youth Sunday School classes, divided by age, and a nursery, along with an adult Sunday School. Many of our children attended the Diocesan Church Camp, and several adults acted as counselors.

We are working toward getting out a bit more into our community. Members volunteer to read to the children at our "adopted' nearby grade school weekly, and we provide school supplies and gifts to the teachers. Volunteers have also been assisting St. Benedict's Abbey with sorting and distributing food at their weekly food pantry. St. Mike's is in the "baby steps" of teaming with a local nursing home to help provide for their needs, and also to do some onsite programs (Christmas caroling, etc.).

While we continue to have the usual surprise items, we are working hard to plan out a multi-year maintenance/upgrade program on our physical facility (which includes the DOQ offices and Mission Center) to minimize the impact to both our budget and the diocese's.

### CHRIST CHURCH, MOLINE

Our Sunday attendance remains strong and just about every parishioner attends at least twice a month. We hold two very strong Bible Studies. Tuesday nights see the young families with children gather for a meal and then study while the children are cared for in a different part of the building. Wednesday nights, after the Eucharist and a meal a more "mature" group meets to study. This year we are doing 1 & 2 Timothy. The Wednesday study is to be found on the Parish Facebook page. Our streaming of our Sunday Eucharist is still touching lives throughout the world and with a dedicated group of operators this remains a powerful and effective ministry. We have received positive responses to weekly emails sent out to the Parish. A thought to ponder, notices of meetings and events plus the duty roster for the following two weeks keep people up to date with Parish happenings.

Our parish has had continued success in reaching our Karen Community with the teaching of the ALPHA Course on the third Sunday of the month after the 10am Eucharist and a meal. This year, we introduced the JUNIOR ALPHA Course to about 10 teens. Once a month after the 10am Eucharist and a meal.

Our Daughters of the Holy Cross group continues to grow and remains a very strong prayer ministry, amongst other things, within the Parish. Our Men's Fellowship has taken on a new ministry of serving a meal once a month at Christian Care. Four servers at a time provide the manpower to serve over 70 people a meal prepared by the center.

Initiated by our Karen community we have had a very successful fundraising day over Memorial Day weekend and a wonderful Parish Picnic over the Labor Day weekend. Fellowship remains a very strong feature of our Parish identity. Guests remark upon it when they are warmly welcomed! Some have returned and even some have become members of the Parish.

Recovery after our settlement of the Lawsuit is slow but moving at a steady pace. We have one more year before we hope to be fully recovered. We lost some longtime members of Christ Church this year which has made the recovery a little more challenging.

The training of our curate, Fr Michael Lindstedt, is a blessing not only to the Parish but to the Diocese as we look forward to the role of this Parish in the future growth and development of the Diocese with strong leadership.

### ST PETER'S CHURCH, CANTON

We are currently in the negotiation stages of purchasing the building that we have been renting for the last 6 years. We had four Confirmations when the bishop visited us.

### ST MARK'S, SILVIS

This year we continue our support of the bishop's vision for spreading the Gospel to our brothers and sisters in Colombia. We also continue to grow in our own congregation as the Holy Spirit continues adding to our numbers. We added a new Furnace and air Conditioner through a capital campaign fund, and our online presence continues to grow.

# **CHRIST CHURCH LIMESTONE- The Old Stone Church**

Our beloved church has jumpstarted 2025 celebrating a special milestone, as we enter into our 180th anniversary since its consecration by Bishop Philander Chase, 10 December 1845! *Historic Christ Church Limestone*, organized a special summer celebration, hosting an Ice Crem Social, were we received many visitors came to our church and WEEK and WMBD news made a special report. We will continue our celebrations during Synod and at a Solemn Eucharist on Sunday, 7 December. Our faith community continues to increase (including the addition of a newborn baby) as we have received individuals and families that are finding a home to worship God and assist us in build His kingdom.

# **Daughters of the Holy Cross**

# The Daughters of the Holy Cross

Who are the Daughters of the Holy Cross?

We are women within the ACNA who seek to grow spiritually by following a rule of life centered around prayer, study, service and evangelism.

When do we meet?

There are no hard rules governing how often or where to meet.

The Chapter at Christ Church, Moline meets either at church or in a member's home. This has allowed a member to still attend meetings while facing medical challenges in her family. We try to meet every month but find that meeting during the winter in the evenings is a challenge.

What is our focus?

As women who are seeking to grow spiritually, we focus on the 4 areas of our rule of life:

**Prayer**: our Chapter maintains a prayer list of people from the parish as well as those outside the parish who have asked for our prayers. We are able to connect with the prayer warriors in the parish within minutes of hearing of a need. This is done through text messages. We are committed to pray for our parish clergy, Bishop and leadership of the ACNA on a daily basis.

**Study**: this year our Chapter is completing Johannes van der Bijl's book "Breakfast on the Beach – the development of Simon Peter" and are looking for a new book to study in the fall. We only read or discuss 1 chapter a month so it takes us quite a while to get through any book study. Each Daughter is also a regular attendee at a bible study within our church.

**Service**: being a small group has its advantages as we are able to respond quickly to needs within our community. We have continued our support of a local nursing home as well as Pregnancy resources but have also been able to respond to urgent needs at our shelters by providing warm clothing during the winter and bottles of water for the homeless during the extremely hot days during the summer. We have joined forces with our Anglican Church Women's group in their service projects as well.

**Evangelism**: this is not everyone's comfort zone but we discuss it at every meeting as we learn from each other. Standing on a street corner holding a sign is not for most of us, but we learn how to evangelize by our kindness and care shown to those who so desperately need Jesus.

Our earnest prayer is that other ladies (or young ladies 12 – 18 years old) will discover the Daughters of the Holy Cross. The Daughter's group at Grace Anglican Church, Galesburg has unfortunately closed due to members facing health issues and unable to attend meetings. Christ Church has invited those ladies to attend their meetings instead if they would like to. We who are members have found it a great source of encouragement as we walk this road together. It only takes 3 ladies to make up a Chapter, so if your congregation has 3 ladies who are seeking to grow in their faith, you already have the nucleus for a Chapter. Please feel free to contact me or any of the Daughters in the Diocese for help in starting a group.

# <u>Franciscan Order of the Divine Compassion (FODC)</u>

The Franciscan Order of the Divine Compassion was founded on *October 4, 1991*, by the late *Rt. Rev. Br. John Charles Vockler*, who at the time was Vicar of Trinity Church, Monmouth IL. He was assisted by the late Jack Couch of Trinity Church, Rock Island IL. After Br. Jack died and Br. John Charles moved on from our Diocese (and eventually returned to his native Australia), Bishop Keith Ackerman became both Bishop Protector and Minister-General of the Order. As the Order grew and expanded, first in the Episcopal Church and then as an ecumenical international Anglican Order, people seeking a Franciscan approach to Christianity joined from around the world. There are currently about 150 members in North America, Europe, England, Africa, and Asia.

Vocations are secular in nature: members live in the regular world. Although under vows and promises, members live the "religious life" in their own homes. follow the way of the Cross and become a symbol of Christ in a world that often rejects the love of God and the salvation through our Lord and Savior Jesus Christ.

# MINUTES of the 147th Synod of the DIOCESE OF QUINCY

# October 17, 18, 19, 2024 at Embassy Suites- East Peoria, IL

# Day One

The 146th Synod of the Diocese of Quincy was called to order at 10:05 a.m. on October 18, 2024, at the Embassy Suites in East Peoria, Illinois by the Right Reverent Alberto Morales, IX Bishop of Quincy. The Bishop extended his welcome to *The Right Reverent John Boonsaaijer*, president of the Board of Foreign Missions for the REC. The Bishop then appointed Bp. Boonsaaijer as Chaplain to the Synod and asked him to give the opening prayer, which he did. Bishop Morales welcomed all in attendance and called Synod to a moment of silence in memory of clergy who had answered the heavenly call over the past year and dedicated this Synod to the glory of God in their honor:

Bp. Morales called Becky Karlowicz and Amanda Pauley to give a presentation on the Anglican Church Camp of the Midwest. They reported on another successful camp.

Fr. Alexander Triana was then called upon to give a presentation on his mission in Medellin, Colombia.

Bp. Morales then called upon Fr. Gabriel Herñandez-Monrreal to give a presentation on his mission in Monterrey, Mexico.

After a short break, Bishop Morales called upon Cn. Shawn Doubet, Secretary of Synod, to give additional details regarding the conduct of business and to certify that there was a quorum in both orders.

Cn. Doubet then presented the rules of order as follows.

### **Rules of Order**

### General

In any question of procedure, Robert's Rules of Order will guide the conduct of business.

### Debate

- 1. Debate shall be limited to 2 minutes per member on any motion or question.
- 2. A member may speak to a given motion or amendment only once.
- 3. As far as possible, the Chair shall allow members in favor of, or opposed to, a question to speak alternatively.

# **Motions Not Previously Published**

A resolution not previously published to the members of the synod may be brought to the floor by any two clergy or the deputations of any two congregations; provided that if the resolution involves an amendment to the Canons, the proposal may be received for consideration only on a motion adopted by 3/4 of the synod (canon 141.4). If accepted, the proposal shall be referred to the Committee on Constitution and Canons for review and recommendation, within instruction that it be reported back before the end of Synod. Once reported by the Committee, such resolution may be considered and acted upon in the same manner as if it had been filed prior to Synod.

Since these rules had been approved previously by the 138<sup>th</sup> Synod, they did not require a vote.

Cn. Doubet then certified there was a quorum present in both orders.

The Bishop then called upon Cn. Michael, Canon to the Ordinary, to present the following motions regarding membership of the Synod.

Cn. Strachan stated that all the canonical requirements having been met, he moved that St. Mary's, Ft. Wayne, IN, and St. Anthony, Huron, SD be admitted as missions into union with the Synod of this Diocese and that their deputies therefore be granted seat, voice and vote.

The Bishop called for any discussion and there being none called for a vote. The motions carried.

Cn Strachan then asked that these chapels/church plants be granted Seat and voice:

Bishop Morales called upon Cn Doubet, Secretary of Synod to present the minutes of the 147th Synod for certification. Cn Doubet stated that the minutes of the prior Synod having been published on the diocesan website, asked if there were any additions or corrections. Hearing none he moved they be accepted as presented. The motion was seconded and carried. Cn. Doubet also moved that the administrative reports in the Journal be accepted as presented. The motion was seconded and carried.

Bishop Morales then made the following appointments.

The Bishop then asked for a motion and second to approve these appointments. Motion was made, seconded and carried.

# Break for lunch

After reconvening after lunch, Cn. Doubet stated that the following appointments were made by the Bishop to serve as the Committee of Elections.

The Bishop then called upon Cn Strachan to present the report of the Committee on Nominations.

Cn Strachan stated that the following positions need to be filled by election:

One clergy and one lay person for three-year terms on Standing Committee. Candidates are

- Fr. William Anderson, from St. Peter's Church, Canton, IL, for the clergy position and
- Mr. Craig Young, from St. Peter's Church, Canton, IL, for the lay position.

# On Diocesan Council,

- One three-year clergy position.
  - o The candidate for this position is Fr. Michael Linstedt from Christ Church, Moline
- There are also two three-year lay positions on Council.
  - Candidates for these positions are Mr. Will Duke from St. John's, Henry, IL and Mrs. Sheryl Diemer from St. Michael and All Angels, Peoria, IL.

One two-year clergy positions on Ecclesiastical Court.

- Candidate for the position is Fr. Lawrance Glenn, St. Mary of the Snows, Eagle River, WI. One two-year Lay position,
  - the candidate is Dr. Don Rager of Christ Church, Limestone, IL

Fr. Roberto Carvajal was nominated for the open clergy position on Standing Committee. The motion was seconded and passed, creating the need for an election.

Preceding the election, there was a motion to pass the non-contested elections by acclamation. The motion was seconded and passed and the slate of non-contested candidates was elected by acclamation of the Synod.

Cn Strachan explained the online voting process

- Paper ballots were distributed to those in present in Peoria who were not able to vote online.
- There was a break as voting concluded and the votes were tabulated
- Fr. Carvajal was elected by a majority in both orders

Following the break and the announcement of the results of the election, Bp Morales asked that Cn Doubet present the report of the Committee on Resolutions.

Cn Doubet reported that there were no resolutions being presented for consideration of the Synod.

The bishop called upon Mark Gamage to present the report of the Trustees of Funds and Properties.

Mark presented the report.

- There was a motion to accept the report as submitted.
- The motion was seconded and passed by voice vote.

The Bp Morales then called upon Cn Dan Kincade, Canon for Finance to present the 2024 Budget.

- Cn Kincade presented the budget and answered questions regarding its content
- There was a motion to approve the budget by ballot, rather than voice vote.
- There was an online vote which passed 80% to 20%

Bp Morales asked Cn Greg Lynn to give his presentation on AMOR and the work that they are doing in Columbia, working with the local priests and ministries to provide for disadvantaged young people.

Bp Morales gave Fr Gabriel the time to complete his presentation from earlier in the day.

Bp Morales asked that Cn Marti Isler give her presentation on the diaconate in the diocese.

Bp Morales asked if there were any resolutions from the floor.

- Fr Larry Glenn attempted to bring a resolution forward that the diocese should provide for a suffragan bishop to assist Bp Morales
- Cn Raskopf stated that this resolution was out of order
  - Fr Glenn agreed to a motion that the diocese would investigate this prospect and process over the next year
  - ➤ The motion was seconded and passed by voice vote.

There was a motion to adjourn which was seconded and passed by voice vote.

Fr Payton Wieland made housekeeping announcements as the host of the event regarding the upcoming Healing Mass and Synod Banquet.
